4. **Onshore application** for **Australian based** Employees/Contractors or Australian Citizens requiring an ASIC, Aviation Corporate Card or IT Access

It is a requirement for all onshore employees and contractors to pass a background check application that includes an Auscheck/ASIC (ASIC – Australian Security Identification Card) clearance check and a nationally coordinated criminal history check administered by the Australian Criminal Intelligence Commission (ACIC) via the National Police Checking Service. These checks need to be completed whether your job requires a physical ID card or not. One application form is filled in and is then sent to the following two checking partners:

- The ASIC application will be submitted to and reviewed by the government agency, AusCheck.
- The ACIC application will be submitted to and reviewed by the government service, the National Police Checking Service administered by the Australian Criminal Intelligence Commission.

Depending on the position/operational requirements of a job and after successful completion of an onshore application an individual may be entitled to the following card types:

Copies of your Identification documents must be verified and signed by a Qantas approved person and then uploaded into your application. Refer to Section 11 for Qantas approved person definition.

- Each type of document can only be used in one category i.e. a Passport cannot be uploaded as a Category B and then uploaded again as a Category C document.
- If any Identification documents **are not in English**, **they must be accompanied by a professionally translated** document. The original document and the translated document must be submitted. Both documents must be verified and signed by a Qantas approved person.
- All Identification documents must be current expired Identification documents will <u>not</u> be accepted.
- If Identification documents contain different name/s, an additional Linking Document must be submitted.

Local Police Certificate Requirements

- It is a requirement that if applicant has lived outside Australia within the last 12 months, a police certificate or equivalent is required from that country of residence to be submitted as part of the ASIC application. If the applicant has lived in more than one country within the 12-month period, a police certificate is required from each country of residence.
- Any Local Police Certificate supplied must be no more than 12 months old at the time of submission.
- Documents that are not in English must be accompanied by a professionally translated document.

5. **ASIC application** for **New Zealand Citizens** employed as Flight Crew or Cabin Crew

The ASIC application will be submitted and reviewed by the government agency AusCheck.

This section is applicable to individuals who meet the following criteria:

- New Zealand citizens;
- Employed as Flight Crew or Cabin Crew;
- Are not in Australia for a period of more than 12 consecutive hours during the ASIC application process, prior to the ASIC being issued; and
- Do not have a current Australian Visa or Australian citizenship.

An individual may be entitled to the following card type:

Local Police Certificate Requirements

- A police certificate is required from the local New Zealand Authority, i.e. Ministry of Justice.
- If the ASIC applicant has lived outside New Zealand within the last 12 months, a police certificate from that country of residence to be submitted as part of the ASIC application.
- Any NZ Police Certificate supplied must be no more than 12 months old at the time of submission.
- Documents that are not in English must be accompanied by a professionally translated document.

Identification Documents required by AusCheck

Copies of your Identification documents must be verified and signed by a Qantas approved person and then uploaded into your application. Refer to Section 11 for Qantas approved person definition.

- Each type of document can only be used in one category i.e. a Passport cannot be uploaded as a Category B and then uploaded again as a Category C document.
- If any **Identification documents are not in English**, they must be accompanied by a professionally translated document. The original document and the translated document must be submitted/uploaded. Both documents must be verified and signed by a Qantas approved person.
- All Identification documents must be current expired Identification documents will <u>not</u> be accepted.
- If Identification documents contain different name/s, an additional linking document must be submitted.

6. ASIC Application for Flight Crew or Cabin Crew based outside of Australia who are non-Australian or New Zealand citizens

The ASIC application will be submitted to and reviewed by the government agency AusCheck.

An individual may be entitled to the following card type:

Local Police Certificate Requirements

- A police certificate is required from the country of residence to be submitted as part of the ASIC application. If the applicant has lived in more than one country within the 12-month period, a police certificate is required from each country of residence.
- Any Local Police Certificate supplied must be no more than 12 months old at the time of submission.
- Documents that are not in English must be accompanied by a professionally translated document.

Identification Documents required by AusCheck

Copies of your identification documents must be verified and signed by a Qantas approved person and then uploaded into your application. Refer to Section 11 for Qantas approved person definition.

- If any Identification documents are **not in English**, they must be accompanied by a **professionally translated document**. The original document and the translated document must be submitted. Both documents must be verified and signed by a Qantas approved person.
- All identification documents must be current expired Identification documents will <u>not</u> be accepted.
- If identification documents contain different name/s, an additional linking document must be submitted.

7. **Offshore application** for **Offshore based** Employees/Contractors requiring an Aviation Corporate Card or IT Access

Applicants are required to submit:

- 1. 100 points of identification using any combination of primary and/or secondary documents; and
- 2. A police certificate or equivalent. Refer to Table A in Section 9 Acceptable Offshore police certificate or equivalent documents by country.
 - If the applicant has lived in more than one country in the last 12 months, a police certificate or equivalent is required from each country of residence.
 - The police certificate or equivalent does not need to be verified unless the document is **not** in English.
 - Any Local Police Certificate supplied must be no more than 12 months old at the time of submission.
 - If the police certificate or equivalent is **not in English**, a **translation of criminal record (can be completed by Qantas Manager fluent in the local language)** is required. Also, a Qantas Manager or notary must:
 - a) Check that the name and date of birth match on the primary and secondary document
 - b) Once confirmed, write the following on the scanned copies of the primary and secondary document:
 - "I (insert name), confirm that the applicant's primary and secondary document contains the same name and date of birth"
 - > their full name, signature, date and if applicable staff number

Identification Documents

Copies of your Identification documents must be verified and signed by a Qantas Manager or a notary and then uploaded into your application. Documents for this application type can be verified over a video call.

All identification documents must be **current** – expired Identification documents will **not** be accepted.

- If the primary or secondary document is not in English, a translation of criminal record (can be completed by Qantas Manager fluent in the local language) is required. A Qantas Manager or notary must:
 - 1. Check that the name and date of birth match on the primary and secondary document
 - 2. Once confirmed, write the following on the scanned copies of the primary and secondary document:
 - "I (insert name), confirm that the applicant's primary and secondary document contains the same name and date of birth".
 - their full name, signature, date and if applicable staff number.

8. Identification Documents required for an ACIC Background Check for Australian based Employees/Contractors

The application will be submitted to and reviewed by the government agency, ACIC.

Each document type can only be used in one category i.e. a passport cannot be used as a category A and B document.

If the applicant has lived outside Australia within the last 12 months, a police certificate is required to be submitted as part of the onshore background checking process. If the applicant has lived in more than one country within the 12 month period, a police certificate is required from each country of residence. The police certificate does not need to be verified.

If any identification documents are not in English, they must be accompanied by a professionally translated document. The original document and the translated document must be submitted. Both documents must be verified and signed by a Qantas approved person.

A renewal application must be completed every two years and may be requested earlier at the direction of Qantas Group Security.

Identification Documents required by ACIC

If the applicant has lived outside Australia within the last 12 months, a police certificate or equivalent is required from that country of residence.

Identification documents must be signed by a Qantas approved person. Refer to Section 11 for Qantas approved person definition.

All identification documents must be **current** – expired identification documents will not be accepted. If identification documents contain a different name/s, an additional linking document must be submitted.

9. Table A – Acceptable Offshore Police Certificate or Equivalent

The table below identifies the police certificate equivalent documents that can be provided when a person lives/ has lived outside of Australia in the last 12 months.

- If the applicant has lived in more than one country within the 12-month period, a police certificate is required from each country of residence.
- If both a police certificate and Aviation/Airside ID types are ticked in the table, only one is required to be uploaded in the application.
- Any Local Police Certificate supplied must be no more than 12 months old at the time of submission.
- An Aviation/Airside ID is an identification card issued by local airport or Government authority that permits working airside.
- Statutory Declarations are the only acceptable equivalent documents in certain countries and in certain circumstances.

10. **ASIC Verification – for contractors** holding a valid ASIC issued by another Issuing Body (not Qantas) that need access to Qantas Group property and/or IT access

If you are a contractor, have a valid ASIC issued by another issuing body and require access to Qantas IT only, your application card type is **ASIC Verification – IT access only**.

If you are contractor, have a valid ASIC issued by another issuing body and you require access to Qantas facilities managed by Qantas door readers and/or Qantas IT, your application card type is **ASIC Verification – Contractor Card**.

Depending on your operational requirements and after approval of an ASIC Verification you may be eligible for the following:

Your current valid ASIC will be validated via the Department of Home Affairs Auscheck Portal.

The validity of the Qantas security clearance will be matched to the validity of the ASIC submitted in the application. The applicant will be required to complete another application when their ASIC (issued by an issuing body other than Qantas) is renewed or changes issuing body. **Access will be revoked upon expiry** if a new application has not been submitted before the clearance expires.

ASIC Verification Applicants are required to submit:

- 1. 100 points of identification using any combination of primary and / or secondary documents; and
- 2. A clear colour copy of their valid ASIC

Identification Documents required

Identification documents **DO NOT** need to be verified or signed.

All Identification documents must be current - expired Identification documents will not be accepted.

11. Verifying Identification Documents

What documents need to be verified?

Identification documents submitted as part of an ID application must be verified (reviewed and signed by a Qantas approved person). The only exceptions to this are documents that do not have an original i.e. background/police check or VEVO certificates. Digital drivers license and digital medicare documents do not need to be verified but you must provide full details.

Can the same identification documents be used to renew my ID card?

Yes, the same Identification documents may be submitted, **however** the copies of the identification documents must be verified again, you cannot use copies of a previous applications verified identity documents.

A 'Qantas approved person' is anyone who meets the following conditions:

- A Qantas employee (must hold a current Qantas ASIC or a Corporate Aviation ID holder who has transitioned to the 2 year ASIC background check):
 - In the same business unit as the ID applicant;
 - In a senior position to the applicant; and
 - Employed in one of the following roles:
 - Group Executive or Senior Professional (or equivalent)
 - Group Manager or have direct reports visible in Workday with Supervisory Org
 - Group Captain (can only certify Identification documents for other Captains or Pilots)
 - Group Cabin Crew Ground Manager
 - Talent Acquisition team
 - Supplier Manager or Co-ordinator who has written approval from Qantas ID Security to verify.

If there is no one at your location who meets the conditions above, please email <u>idsecurity@qantas.com.au</u> and request for a local representative to be added to the 'Approved Identification Document Verifier's list. Once the representative has been added to the list, they can verify Identification documents.

12. ID Photo Requirements

The photo submitted as part of an ID application will be printed on the ID card. Your photo is submitted to Government as part of your application, photos that are not compliant will result in your application being rejected.



Examples of suitable and unsuitable photographs

Non-compliant images - these types of images will not be accepted

The photo must meet all the following requirements:

- good quality, color, glossy print no filters or editing the photo;
- less than six-months-old;
- clear, focused image with no marks or 'red eye';
- plain white or light grey background that contrasts with the applicant's face;
- uniform lighting (**no shadows or reflections**) with appropriate brightness and contrast to show natural skin tone;
- face not tilted in any direction, looking directly at the camera;
- no glasses **
- hair off the face so that the edges of the face are visible;
- eyes open, mouth closed;
- neutral expression (not smiling, laughing or frowning); and
- smart attire.

Facial Coverings

- If the applicant usually covers their head or wears facial jewelry for religious or cultural reasons, these can be included in the photo provided that they do not obstruct or cover facial features.
- Head coverings should be plain colored and must be worn in such a way as to show the face from the bottom of the chin to the top of the forehead, with the edges of the face visible. They should be worn in such a way as to minimise shadows and obstruction of facial features.

<u>Jewelry</u>

• Jewelry must not obscure any part of the face, especially the area around the eyes, mouth and nose. There must be no reflection from rings or studs.

**Glasses (ASICs only)

• Glasses are <u>not allowed</u> in photos. In rare cases they may be permitted where glasses cannot be removed for medical reasons (e.g. severe light sensitivity or recent eye surgery). Vision impairment alone is not sufficient for medical exemption. If glasses must be worn for medical reasons:

a) the frames must not obscure the eyes and there must be no reflection from the lenses; and

b) a medical certificate is required. The medical certificate must:

i. be signed by a registered medical practitioner;

- ii. state the reason why glasses cannot be removed;
- iii. include the medical practitioner's full name, registration number and the address and phone number of the medical practice.

If the photo submitted does not meet all the requirements above, the ID application will be rejected which will delay the application processing time.
